#### Focus on Membership—RC Hutchinson has a new program

The Rotary Club of Hutchinson has started an Associate Membership program, made possible by the new Council on Legislation enactments.

The **Associate Membership** program is open to any member of the Reno County Young Professionals organization (YP). Members of YP can join Rotary for up to one year without paying membership dues. They pay only for meals at meetings they attend. After one year, associate members will be asked to become regular members.

The goal is to help recruitment efforts for the demographic that YP covers--those aged 25-40. Associate members will experience the benefits of Rotary and have the chance to "try on" membership before either paying the cost themselves or asking their employers to sponsor them.

Our club has already brought in two YP members through this program, and will introduce three more at the December 19th meeting. We are very excited to welcome these members and show them the value of being Rotarians!

#### Corporate Membership and New Membership Types



Are you interested in offering new membership types in your club? Robert Fisher, of the Rotary Club of Melbourne, Victoria, Australia, recently described his experience with corporate memberships. <u>Learn</u> how his club applied this new flexibility to increase membership.

Here's what clubs need to know about corporate memberships and other new membership types:

- Clubs are free to offer alternative memberships of any kind. For corporate memberships, clubs count individuals as members, not the corporations that sponsor them.
- If corporate members pay RI dues, they will be included in their club's official membership count and receive all the benefits that other active, dues-paying members enjoy.
- Clubs can have special policies for these members' other financial obligations (club and district dues, meal costs, etc.), attendance requirements, or service expectations, as long as the club bylaws reflect these policies.

#### Open World Program coming to RC Hutchinson

The Rotary Club of Hutchinson has been approved to host a delegation from Ukraine next year for the Open World Program.

OM OM OPEN WORLD

Rotary clubs are given an opportunity to host six-participant delegations for eight days and nights and prepare a professional program related to business, community, and civic life in the United States.

The Open World Program is available only to Rotary clubs in the United States, and provides an opportunity to build fellowship and friendship to strengthen international understanding by hosting emerging Eurasian leaders from Azerbaijan, Kazakhstan, Kosovo, Kyrgyzstan, Russia, Serbia, Tajikistan and Ukraine in your community.

The exchange with the Hutchinson club will take place over October 13-21, 2017, and will focus on showcasing civic education in the U.S. to a delegation representing secondary schools.

#### ShelterBox moves its headquarters

In July, Cornwall-based international disaster relief charity <u>ShelterBox www.shelterbox.org</u> moved its headquarters to Truro, keeping its warehousing and aid-packing base in Helston.

On 10 November, I made my first visit to Falcon House, now that ShelterBox has relocated most if its staff, including its operational and fundraising teams, into my Truro and Falmouth constituency. The visit was hosted by Chief Executive Chris Warham, my first chance to meet him since Chris's appointment in July.

In 2013 I was pleased to help arrange a week-long exhibition for ShelterBox in the Palace of Westminster, and a special reception event attended by Ministers and Members of Parliament that led to the growth of donations from more parts of the country.

I am delighted that ShelterBox is now headquartered in Truro. I was interested to learn that this year ShelterBox has provided shelter for over 120,000 people from Haiti to Iraq and Syria, people who have been made homeless as a result of natural disaster or conflict. I very much support their vision to help 1 million people by 2025 and will con-



tinue to do all that I can to help them deliver their mission of "no family without shelter."

During the visit I saw the charity's visitor centre,



which shows the growing range of ShelterBox aid including different types of tents, Shelter Kits and School Boxes. In the Operations room I also had a briefing on current deployments from Operations Manager Alf Evans, and heard about our work preparing to help people fleeing Mosul from Operations Coordinator Sam Hewett, who was leaving the next day for Erbil in Iraq.

I also discussed ShelterBox's valuable relationship with Rotary, as I am a Falmouth Rotarian myself. Rotary and ShelterBox go hand in glove, an incredibly important partnership. ShelterBox sprang out of Rotarians' good ideas, what more they could do, and it is brilliant to see that relationship continue year after year and go from strength to strength. Rotary is a global organization with trusted people in communities all over the globe. It is just a brilliant group of people that ShelterBox can work with in an emergency to get aid to where it's needed.

#### The Gifts of Volunteering

During this season of giving, it is interesting that volunteering gives us a gift.

Our volunteering through Rotary (as well as other ways we give back to our community) has many benefits. So here is a gift to you from your volunteering through Rotary:

Perhaps the first and biggest benefit people get from volunteering is the satisfaction of incorporating service into their lives and making a difference in their community and country.

The intangible benefits alone—such as pride, satisfaction, and accomplishment—are worthwhile reasons to serve. In addition, when we share our time and talents we:

- Solve Problems
- Strengthen Communities
- Improve Lives
- Connect to Others
- Transform Our Own Lives

However, one of the best gifts given to us as we volunteer through Rotary may be a positive benefit to your health

Over the past two decades we have also seen a growing body of research that indicates volunteering provides individual health benefits in addition to social ones. This research, which is presented by Corporation for National Community Service in a report titled "The Health Benefits of Volunteering: A Review of Recent Research," has es-

tablished a strong relationship between volunteering and health: those who volunteer have lower mortality rates, greater functional ability, and lower rates of depression later in

life than those who do not volunteer.

Comparisons of the health benefits of volunteering for different age groups have also shown that older volunteers are the most likely to receive greater benefits from volunteering, whether because they are more likely to face higher incidence of illness or because volunteering provides them with physical and social activity and a sense of purpose at a time when their social roles are changing.

Some of these findings also indicate that volunteers who devote a "considerable" amount of time to volunteer activities (about 100 hours per year) are most likely to exhibit positive health outcomes.

#### RC Dodge City helps NUMANA



On the morning November 5<sup>th</sup>, several Dodge City Rotary members, family and friends joined forces with the Dodge City NU-MANA event. The event was to package and box

dry food to feed thousands of the hungry in Southwest Kansas and for the hurricane ravaged people of Haiti.

Dodge City Rotary members helping were President Jeanette Seavet, Past President Nathan Haskell and his two sons, Aiden and Miles, President Elect David Bergmeier, Assistant Governor David Wetmore, his wife Lu, daughter Ashley and nephew Heath Hamilton, Reverend Jerry Nolte and his wife, Jalynn.

Volunteers measured the ingredients, scooping them into meal bags, weigh and seal the bags, and the finished product. The boxes were loaded in trucks to prepare for international shipping.

The meals consist of rice, soy protein, freeze-dried pinto beans and a blend of vitamins and minerals targeted to

On the morning November help the immune system of malnourished people. Each 5<sup>th</sup>, several Dodge City package contains enough food for 6 meals.

The cost of each life-sustaining meal is only 30 cents! This includes all of the ingredients, packaging, administration, and international shipping of the container. All you have to do is supply space for the event, volunteers to package the food, and the 30 cents per meal.

The containers of food are shipping to our partner organizations around the globe, who distribute the meals as needed. They are used to promote education, encourage school attendance, improve health and so much more!

70,000 meals were packaged in Dodge City. 20,000 meals will stay in Southwest Kansas to feed the hungry. The remaining 50,000 meals will be shipped to Haiti. The left over supplies were given to local food pantries. Norma Henton, Dodge City NUMANA organizer, said they were very pleased with their 2016 event, They raised in excess of \$20,000 to feed the hungry. Norma expressed how much she appreciated the 800 volunteers that helped to make the day a success. It was a very rewarding experience for the Dodge City Rotary members.




Rotary Club W. Wichita: Several members purchased and delivered groceries for our 4 families from Lawrence Ele-

#### **End-of-Year Giving Deadlines**

Make sure you are prepared for calendar year end giving and are familiar with the deadlines for contributions to The Rotary Foundation.

- Online contributions need to be authorized by midnight, 31 December 2016 CST
- Credit card contributions made via fax (847-328-5260), phone (866-976-8279), and mail must be received prior to the close of business (5pm CST) on Friday, 30 December 2016
- Check contributions must be postmarked by 31 December and must be received by 5 January 2017.
